No. 2/1/2023-1H (C) Dated Chandigarh the جمع , حمع , ORDER UNDER SECTION 5 OF INDIAN TELEGRAPH ACT, 1885 AND RULE 2 OF TEMPORARY SUSPENSION OF TELECOM SERVICES (PUBLIC EMERGENCY OR PUBLIC SAFETY) RULES, 2017

- 1. Whereas, it has been brought to my notice by ADGP/CID/Haryana as well as Deputy Commissioner, Faridabad vide their requests dated 31.07.2023 that there is a likelihood of causing communal tension, annoyance, obstruction and injury to persons, danger to human life and public property, disturbance of public peace and tranquility in district Faridabad in view of the law & order situation arouse in the adjourning district Nuh.
- 2. And whereas, there is a clear potential of disruption of public utilities, damage to public assets and amenities and disturbance of public law and order in district Faridabad on account of misuse of internet services by way of spread of inflammatory material and false rumours, which are being/could be transmitted/circulated to the public through social media/ messaging services on mobile internet services, SMS services and other dongle services.
- 3. In order to stop the spread of misinformation and rumours through various social media platforms, such as WhatsApp, Facebook Twitter, etc. on mobile phones and SMS, for facilitation and mobilisation of mobs of agitators and demonstrators who can cause serious loss of life and damage to public and private properties by indulging in arson or vandalism and other types of violent activities.
- Now, therefore, in exercise of powers conferred upon me by virtue of Section 5 of Indian 4. Telegraph Act, 1885 to be read along with Rule (2) of Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017, I, Home Secretary, Haryana do mobile internet services suspension of the order the hereby (2G/3G/4G/5G/CDMA/GPRS), all SMS services (only bulk SMS & excluding banking and mobile recharge) and all dongle services etc. provided on mobile networks except the voice calls in the territorial jurisdiction of district Faridabad of Haryana State. All telecom service providers of Haryana are hereby directed to ensure the compliance of this order.
- 5. This order is issued to prevent any disturbance of peace and public order in the jurisdiction of district Faridabad in the state of Haryana and shall be in force w.e.f. 31.07.2023 (19:30hrs) to 02.08.2023 (23:59 hrs) in district Faridabad. This order is being passed ex-parte in view of the emergent situation as explained in earlier paragraphs. Any person found guilty of violation of aforesaid order will be liable for legal action under relevant provisions.
