In pursuance of Government Order No. 30/44/2008-2HG-III dated 20.04.2021, Smt. Navraj Sandhu, IAS (Retd.) has been appointed as Chairperson and as Members (Sh. K.K.Mishra, IPS, Retd. and Sh. R.C. Verma, IAS, Retd.) of State Police Complaint Authority as per provisions contained in section 59 (2) (c) of Haryana Police Act 2007 (Amended in 2014) and they have assumed the charge of office on 20.04.2021 (afternoon). Further, the Governor of Haryana is pleased to fix terms and conditions of salary, allowances and other service conditions of service of a Chairperson as well as Members as per section 61(2) of Act 2007 (amended in 2014) as under:-

- 1. **Term of Police:** As per section 61 of section of Haryana Police Act 2007 as amended in 2014, the tenure of office will be 3 year.
- 2. Salary, Allowance and other facilities:
 - (i) Chairperson: The pay of chairperson of the State Police Complaint Authority will be equivalent to last pay drawn minus pension or equivalent to the pay of Chief Secretary to the Govt. Haryana minus pension, whichever is higher.
 - (ii) Members: The pay of Members of State Police Complaint Authority will be equal to last pay drawn minus pension or equivalent to the pay of Principal Secretary to Govt. Haryana minus pension, whichever is higher. However, in any circumstances the salary drawn by the members of State Police Complaint Authority will not be more than the salary drawn by Chairperson of State Police Complaint Authority.
- 3. **D.A.:** Chairperson/Members shall be entitled to draw dearness allowance as admissible under instructions of the State Government.
- 4. **Accommodation:** Chairperson/Members will be entitled to Government accommodation of the same category and under the same terms and conditions of the Chief Secretary to Government, Haryana / The Principal Secretary to Government of Haryana in case she/he does not avail of official accommodation she/he will be entitled to House Rent allowance Rs. 50,000/- for Chairman and Rs. 40,000/- for Members per month respectively.
- 5. **Conveyance:** Entitlement of conveyance will be as per Govt. instruction issued vide letter no. 2/6/2005-RVA dated 02.07.2021.
- 6. **T.A./L.T.C.**: Chairperson/Members will be entitled to receive allowances to reimburses them for travelling on duty as admissible Chief Secretary to Government Haryana/Principal Secretary to Government, Haryana as amended from time to time and will also be entitled to L.T.C. on the same pattern. The power to grant of L.T.C. shall vest with the State Government.
- 7. **Medical Reimbursement:** Chairperson/Members as well as family members's dependent on her/him will be entitled to facilities as per provision of the All India Services (Medical Attendance) Rule, 1954 and the instructions issued there under by the Government of India/Government of Haryana.
- 8. **Leave:** Chairperson/Members will be entitled for leave as applicable to Members of Indian Administrative Services.
 - (a) Authority to grant or refuse leave shall be Administrative Department in case of Chairperson and in case of Members, the Authority will be Chairperson, State Police Complaint Authority.
 - (b) Encashment of earned leave:
 - AS per Note rule 65 of HCS (leave) rules, 2016
- 9. **Headquarter:** The Headquarter of Chairperson/Members of the State Police Complaint Authority, Haryana will be at Chandigarh/Panchkula.

- Other Terms & Conditions: Other terms and condition of the State Police Complaint 10 Authority, Haryana not specifically mentioned above shall be at par with the Chief Secretary to Govt. Haryana in case of Chairperson and Principal Secretary to Govt. Haryana in case of Members.
- (i) The pay and allowances and other service benefits admissible to the 11. Chairperson/Members of the Authority in the above mentioned terms and conditional shall not varied to her/his disadvantage during her/his tenure.
 - (ii) The Officer is entitled to the facility of Books/Newspapers/Periodicals and Hospitality expenses as applicable to the Chief Secretary to Government Haryana/Principal Secretary to Govt. Haryana respectively.
- Telephone / Mobile facilities will be provided as per norms fixed by the Government at 12. office/residence with STD facilities.
- The expenditure will be met out from Home Department, Haryana out of Police Head 13. "2055-Police-101-CID & Vigilance 97-State Police Complaint Authority".
- The Administrative Department for the Police Complaint Authority will be Additional Chief 14. Secretary / Principal Secretary to Government of Haryana, Home Department.
